




Subsequent to the discussion, it was resolved that the following guidelines mentioned below shall be followed:

- Utmost priority shall be given for discipline and every one, student or staff, is bound to follow the rules and regulations of the college and maintain strict discipline.
- 2. Any charge, accusation, or allegation against a student, and which if proved, may subject a student to disciplinary action, must be submitted in writing in complete detail to the principal office promptly by the individual/department making the charge.
- 3. The Principal shall forward the same to the disciplinary committee to conduct a preliminary investigation in order to determine whether disciplinary charges should be preferred. The committee shall consult other parties who may be involved or who have information regarding the incident and review other relevant evidence and submit the report with recommendations to the principal.
- 4. Based on the recommendations, if disciplinary action is required, the principal is empowered to suspend or even expel a student from the college in the interests of the institution.
- Convener shall conduct committee meeting frequently and discuss day to day situation on the campus and if necessary shall inform the chairman.
- If the members of the committee are engrossed in class work, at least one third of the members shall be present to address the issues and take decision.
- Students shall not be permitted to use Mobile Phones inside the college campus.
- 8. Focus shall be laid on the dress code of students.
- Students shall be motivated to inculcate the habits of promptness and strict regularity by strict adherence to punctuality.

- 10. The committee shall restrict loitering, noise-making and idling on the campus.
- 11. The committee shall make frequent rounds on the campus.
- 12. Surprise checking of classrooms and corridors as and when the committee deems necessary shall be done.
- 13. For any on spot issues any staff member present on the scene shall take an active role and report the same to the discipline committee. The discipline committee shall look into the matter.
- 14. The committee shall stay in contact and work in co-ordination with the anti ragging committee and women cell to resolve the student issues.
- 15.In case of ragging issues, the committee in consultation with the antiragging committee shall take the decision.
- 16.The committee shall meet at least once in a month. In addition to this the members shall meet as and when required in pursuance of any issues.

Report

As per the instructions given by the principal (letter dated 06th September 2017) the disciplinary committee met in the CSE Seminar hall on 9th September, 2017 to investigate the complaint given by D. Chandra Sekhar, Mech. Dept., bearing roll number 17-304 on CH. Akhilesh, K. Naga Dheeraj and Galib Saida saying that these three raised altercations during lunch hour near the canteen and finally beat him.

The disciplinary committee called the students and probed deeper into the aspects of the incidents. Discussions were made threadbare subsequent to the enquiry and a picture of the series of issues was drawn as follows:

- 1. J. Saikumar of Mech. Dept bearing roll number 17H71A0328 and T.Lavanya of EEE Dept. bearing roll number17H71A0226 were in love with each other. It was a regular practice for J. Saikumar to visit T.Lavanya in EEE Dept. during lunch hour. After a few days J. Saikumar came to know through T.Lavanya that she maintained friendship with Galib Saida of ECE Dept., bearing roll number 16H71A04B9on face book. Later Galib Saida proposed her and was rejected. Again through T. Lavanya, J. Sai Kumar came to know that Galib Saida possessed some photographs of T.Lavanya in his mobile.
- 2. On 1st September, J. Sai Kumar along with his friend D. Chandra Sekhar approached Galib Saida during the lunch hour near the canteen and insisted him to show the photographs of T.Lavanya that were in his mobile. Galib Saida refused to show the photographs and there were altercations that flared up leading to Galib Saida manhandling D. Chandra Sekhar. During the altercations and manhandling, Galib Saida was supported by CH. Akhilesh and K. Naga Dheeraj.
- 3. D. Chandra Sekhar who was manhandled gave a complaint on Galib Saida, CH. Akhilesh and K. Naga Dheeraj to the Physical Director Mr. SK.Basha.
- 4. The physical director immediately took Galib Saida to ECE HOD Dr. Gurava Reddy and explained the issue. Galib Saida was immediately punished by the HOD. By then it was evening and the Physical director thought of taking the remaining two students to their HODs the following day.
- 5. The following day in the morning, CH. Akhilesh, K. Naga Dheeraj and Likesh(a new member who was not so far on the screen) went on a bike to Rayanapadu, the native place of D. Chandrasekhar. They went to the bus stop of D. Chandra Sekhar and gave him blows for giving a complaint on them. Likesh just accompanied them but was not involved during the exchange of blows.
- After coming to college D. Chandra Sekhar reported the same to the Physical Director.
 These were the findings of the enquiry done by the discipline committee.
