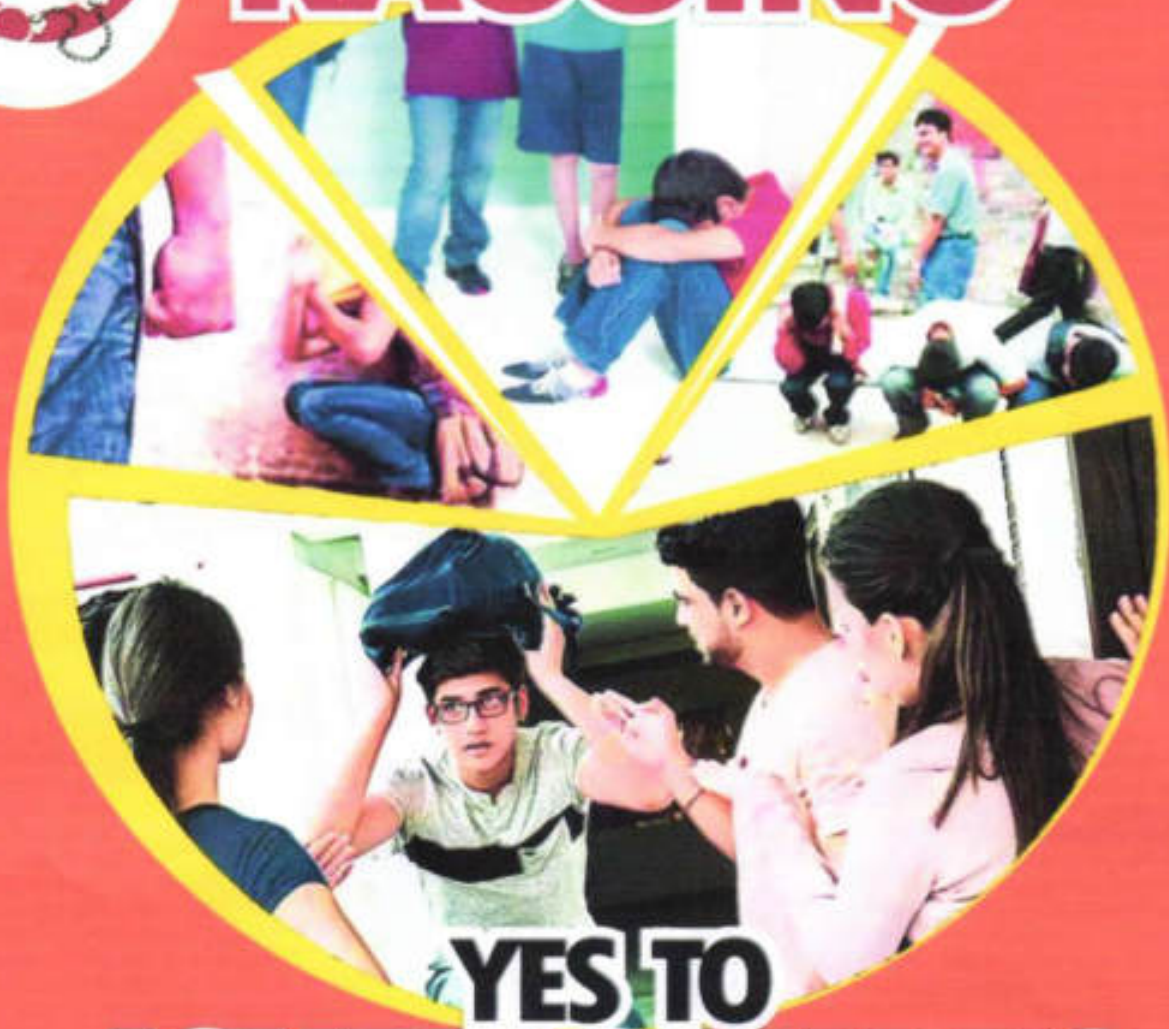

RAGGING IS AN OFFENCE AS PER LAW

- Beware of A.P.Ragging Act 26 of 1997, which invites Punishment
- Ragging within or outside any educational institution is prohibited
- Ragging means doing an act which causes or is likely to cause Insult or Annoyance or Fear or Apprehension or Threat or Intimidation or Outrage of Modesty or Injury to a student
- Ragging invokes Suspension/Dismissal from the College/Imprisonment

A STUDENT INDULGING IN RAGGING CAN BE:

- Cancellation of admission.
- Suspension from attending classes.
- Withholding/withdrawing Scholarship/Fellowship and other benefits.
- Debarring from appearing in any test/ examination or other evaluation process.
- Withholding results.
- Debarring from representing the institution in any regional, national or international meet, tournament or youth festival etc.
- **Collective punishment** : when the persons committing or abetting the crime of ragging are not identified the institution shall resort to collective punishment as a deterrent to ensure community pressure on potential ragger.

The attention of all the Principals of Government and Private Aided Degree Colleges under the control of Commissionerate of Collegiate Education is invited to the subject cited above and in view of the commencement of the class-work for the academic year 2019-20, the following instructions are issued to prevent the incidents of ragging in the institutions.


- a. Erect the suitable hoardings/banners/signboards on anti ragging in all conspicuous places of Higher Education Institutions and display Anti Ragging Provisions and Penalties as per A.P. Prohibition of Ragging Act, 1997 both in Telugu and English.
- b. Display the anti ragging toll free number 1800-425-5314 at the prominent places in the campus to curb untoward activities of the students in Educational Institutions.
- c. Faculty and students must be sensitized on the panel procedures applied as per UGC and AP State Anti Ragging Act.
- d. UGC film on anti ragging (available on UGC website ugc.ac.in) may be screened to students.
- e. An 'Anti Ragging Committee' may be constituted at College level with efficient Senior teaching /non-teaching Staff members and students to prevent ragging and to maintain discipline in the campus.
- f. Representatives from civil, police, local media, NGOs, parents and student organizations are included in anti ragging committee with an aim of familiarizing the anti ragging policy in an effective manner.
- g. Display the details of Anti Ragging Committee with phone numbers in all conspicuous places of the Institution, immediately.
- h. At College level, the anti-ragging committee and squad should be activated and monitored especially at the beginning of the academic session to make the College a ragging free campus.
- i. The ARC shall send a report in the prescribed format by 30/07/2019 to the mail ID tappal-col@ap.gov.in (A Google spread sheet will be sent to colleges before a week).
- j. The ID college Anti Ragging Committee coordinator shall act as District coordinator and shall send the consolidated status of reports of district colleges in excel sheet (each college information shall be written in one row without merging the cells, for this Alt+enter keys will be used) to mail ID tappal-col@ap.gov.in
- k. The RJDCEs shall conduct a review meeting with the district coordinators and all other district college ARC members for every 3 months, i.e., last week of July, 3rd week of October and 3rd week of January. The RJDCEs shall send the district reports for their respective zones in the format given to the mail ID tappal-col@ap.gov.in next day after completion of the every review meeting.
- l. A review meeting will be conducted by Spl.CCE through virtual class rooms in between November and December, 2019.

- m. All the Government & Private Aided Degree Colleges in the State of Andhra Pradesh are advised to ensure appointment of Warden, Deputy Warden and Resident Matron to all the hostels and ensure there is proper management of hostels run the campuses/College Premises. The regular employees available in the College shall be posted to the post of Warden and Deputy Warden;
- n. The entry into the College hostels is restricted to inmates through ID cards.
- o. To reduce ragging in the Colleges, separate hostel accommodation in different rooms and blocks is provided for juniors and seniors.
- p. A complaint box is to be arranged at all the hostels to lodge the complaints against ragging and it should be opened regularly by Anti ragging committee to address the grievances if any.
- q. Periodical inspection and cross verification of the date given by various committees (Disciplinary committees, class committees, counseling committees, Supervisory Committees etc..) may be regularly undertaken by the principal and senior faculty members.
- r. RJDCEs shall conduct reviews and monitor the hostels and send the status of hostels in the required format enclosed for every Academic year beginning(July) and end of the year, i.e., in the month of March.
- s. To eradicate ragging, Professional Counselor/Psychologist shall be appointed by the institute to give necessary counseling to the students.
- t. Take immediate adequate measures such as seminars, workshops, lectures by police, district and legal authorities to sensitize the students.
- u. Fix CC-TV cameras in the College campus and Hostel corridors to make the College a ragging free Campus.
- v. All the teachers are strictly instructed to continue in their classes until the next teacher arrives.
- w. The security person at the main gate is instructed to question outsiders for entry, noting all his/her personal details and purpose of visit.
- x. UGC Regulations on curbing the Menace of Ragging earlier issued to all Higher Education Institutions must be scrupulously followed.
- y. It is mandatory for the institution, where the incident of ragging is reported to file a First Information Report (F.I.R.) before the local police authorities. Such reports should also be made to the Civil Authorities and Higher Police authorities for taking necessary action in the matter.
- z. It is the responsibility of the Principals and HODs of the Educational Institutions to ensure a safe campus/College life, conducive to welfare and development of all the students in Colleges

Further, it is informed that the anti-ragging provisions cited in ref (1), (2), (3) and (4) above are available on the Department website and can be accessed through: www.apcce.gov.in and all the Principals of Degree Colleges in the State are hereby directed to initiate above measures and constitute 'Anti Ragging Committees' in their Colleges and send the compliance (in prescribed Annexure enclosed) to the respective District ID College Principals by 30.07.2019. The consolidated information shall be furnished by ID College Principals to the O/o CCE through tappal-col@ap.gov.in by 05.08.2019.

The Government of Andhra Pradesh has initiated several steps to transform Andhra Pradesh State into a Knowledge Society and Education Hub of global standing.

2. The state has made significant progress in this regard. However, certain stray incidents of ragging have come to light, despite strict guidelines / instructions issued from time to time by the Government. Against this backdrop, it is felt necessary to reiterate the main aspects of the Anti-Ragging Policy of Government, to be read with circular instructions, circulars and GOs already issued in the matter, for guidance of all concerned, as follows:

A) Ragging is prohibited within or outside any educational institution.

B) whoever teases or embarrasses or humiliates a student shall be punished with imprisonment for a term which may extend to six months or with fine which may extend to one thousand rupees or with both [or] assaults or uses criminal force to or criminally intimidates a students hall be punished with punishment for a term which may extend to one year or with fine which may extend to two thousand rupees or with both [or] wrongfully restrains or wrongfully confines or causes hurt go a students hall be punished with imprisonment for a term which may extend to two years or with fine which may extend to five thousand rupees or with both [or] causes grievous hurt to or kidnaps or abducts or rapes or commits unnatural offence with a student shall be punished with imprisonment for a term which may extend to five years and with fine which may extend to ten thousand rupees [or] causes death or abets suicide shall be punished with imprisonment for life or with imprisonment for a term which may extend to ten years and with fine which may extend to fifty thousand rupees .

C] It is responsibility of the Head/Manager of educational institution, upon receiving any complaint on ragging, to inquire into or cause an inquiry to be made forthwith and take such action as deemed necessary and he shall be punished in case of negligence.

D) A Review Committee will be constituted by the District Collector as Chairperson and other members will be Superintendent of Police as Vice Chairperson; Revenue Divisional Officer, Sub Divisional Police Officer, College Principal as members. The Committee shall meet twice before the academic session and twice during academic session. Apart from this, the educational institutions should provide for the constitution of a Committee consisting of parents and guardians of the students.

- E] Every Institution shall constitute a Committee to be known as **Anti Ragging Committee** to be nominated and headed by the Head of the institution, and consisting of representatives of Civil society & Police; Local media; Non Govt. organizations; Faculty members; Parents & students.
- F] Every institution shall constitute a smaller body to be known as the Anti Ragging Squad to be nominated by the HOD.
- G] Every institution shall constitute a body to be known as Monitoring Cell on Ragging and coordinate with the affiliated colleges under domain of the University.
- H] No Outsiders other than inmates of the hostels shall stay in the hostels and no outsiders shall stay on campus, whatsoever.
- I] The entry into hostels and Mess shall be by biometric identity only.
- J] The hostel corridors shall have CC-TV cameras fixed.
- K] The biometric data and video footage shall be monitored by third party arrangement to avoid tampering.
- L] A periodical inspection and cross verification of data shall be verified by the administrative staff.
- M] Disciplinary Committees may be constituted at Hostel level, which should be vigilant by conducting several inspections particularly during vulnerable times and at vulnerable places. There shall be student representatives in the committee. The mischievous elements shall be identified and mischievous actions shall be liable for punishment as per the rulebook of the University/college/institution.
- N] A quarterly review of disciplinary measures and facilities with regard to hostels shall be undertaken by the Vice Chancellor/Principal concerned and a status report has to be sent to the Andhra Pradesh State Council for Higher Education/ Commissioner of Collegiate Education/ Commissioner of Technical Education, who shall send consolidated report to Government.
- O] Notice Boards be erected in all conspicuous places of Higher Education Institution and display Anti Ragging Provisions and Penalties as per A.P. Prohibition of Ragging Act, 1997 both in Telugu and English. Details of Anti Ragging Committee with phone numbers be displayed in all conspicuous places of the institution.
- P] Faculty must be sensitized on the provisions of the Act as well as on the panel consequences.
- Q] Seminars, workshops, lectures by police, district and legal authorities be conducted to sensitize the students.
- R] It is the responsibility of the Vice Chancellors/ HODs of other educational institutions to ensure a safe campus/college life conducive to welfare and development of students.



Anti-Ragging Policy Awareness, Avoidance, Action

I. Awareness:

Make the seniors aware of the ills of ragging and its consequences by way of posters, notices and counseling lectures by faculty class-in-charges, HOD's/ Principal/ Director/ Management Representatives/ police department and through undertaking by the students, parents etc.

II. Avoidance:

- 1) Enforcing measures to minimize contact between fresher's and seniors, by staggered lunch and break timings for students of different years.
- 2) Forming anti-ragging squads, and
- 3) By continuous surveillance at vulnerable locations for ragging such as toilets, terraces, canteen, hostels, buses etc.

III. Action:

Whenever a ragging case is reported, to take appropriate action through the discipline committee.

Anti Ragging Measures

1. The Anti Ragging Committee comprising of the college staff, parents, media representatives and police personnel is constituted according to the instructions issued by the AICTE, UGC, and the University.
2. Banners discouraging ragging are displayed at the different locations in the college and hostels.
3. Anti Ragging Complaint box has been placed.
4. An Anti-Ragging Squad which is constituted with the staff and student members is on vigil throughout the day near the class rooms, buses, canteen and hostels.
5. As part of the orientation a counseling session is organized for the I Year students (Freshers) and their parents on the first day of academic session.
6. Surveillance cameras are arranged in the strategic locations.
7. Seminars are arranged to the senior students by the police department to make them aware about the consequences of ragging.
8. Undertaking forms are taken from the senior students and parents after explaining the consequences of ragging.
9. Separate class work timings are maintained for seniors and juniors to avoid their interaction.
10. Anti Ragging feedback is taken from the students to know about ragging.
11. Staff supervisors are arranged in all the buses to curb ragging.

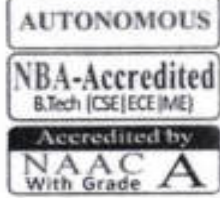

Ragging is different from other crimes because the motive is solely to get perverse pleasure. Ragging is also different from other crimes as it is actively promoted by certain sections of the society.

Following types of abuses and activities will be termed as ragging :

1. Physical abuse - for example forcing to eat, drink or smoke, forcing to dress or undress.
2. Verbal abuse - for example swear words and phrases, direct or indirect derogatory references to the person's appearance, attire, religion, caste, family or chosen field of study.
3. Forced activity - for example Chores for seniors e.g. copying notes, cleaning rooms, etc.
4. Not being allowed to attend classes.
5. Staying awake late or getting up at unreasonable times.
6. Singing or dancing or performing in any other way.
7. Using foul language or shouting or cheering loudly.
8. Misbehaving with strangers, particularly women.

Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following :-

1. Cancellation of admission
2. Suspension from attending classes
3. Withholding/withdrawing scholarship/fellowship and other benefits
4. Debarring from appearing in any test/examination or other evaluation process
5. Withholding results
6. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
7. Suspension/expulsion from the hostel
8. Rustication from the institution for period ranging from 1 to 4 semesters
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

An appeal against the order of punishment by the Anti-Ragging Committee shall lie,

1. In case of an order of an institution, affiliated to or constituent part, of the University, to the Vice-Chancellor of the University;

Anti Ragging Measures

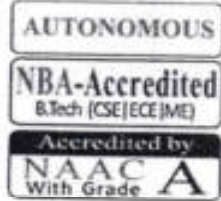
1. The Anti Ragging Committee comprising of the college staff, parents, media representatives and police personnel is constituted according to the instructions issued by the AICTE, UGC, and the University.
2. Banners discouraging ragging are displayed at the different locations in the college and hostels.
3. Anti Ragging Complaint box has been placed.
4. An Anti-Ragging Squad which is constituted with the staff and student members is on vigil throughout the day near the class rooms, buses, canteen and hostels.
5. As part of the orientation a counseling session is organized for the I Year students (Freshers) and their parents on the first day of academic session.
6. Surveillance cameras are arranged in the strategic locations.
7. Seminars are arranged to the senior students by the police department to make them aware about the consequences of ragging.
8. Undertaking forms are taken from the senior students and parents after explaining the consequences of ragging.
9. Separate class work timings are maintained for seniors and juniors to avoid their interaction.
10. Anti Ragging feedback is taken from the students to know about ragging.
11. Staff supervisors are arranged in all the buses to curb ragging.

Punishment for Ragging

The legal definition of ragging is as follows : "Ragging" means the doing of any act which causes, or is likely to cause any physical, psychological or physiological harm of apprehension or shame or embarrassment to a student and includes

Teasing or abusing or playing Practical joke on or causing hurt to any student.

Asking any student to do any act, or perform any thing, which he/she would not , in the ordinary course, be willing to do or perform.



Ragging is different from other crimes because the motive is solely to get perverse pleasure. Ragging is also different from other crimes as it is actively promoted by certain sections of the society.

Following types of abuses and activities will be termed as ragging :

1. Physical abuse - for example forcing to eat, drink or smoke, forcing to dress or undress.
2. Verbal abuse - for example swear words and phrases, direct or indirect derogatory references to the person's appearance, attire, religion, caste, family or chosen field of study.
3. Forced activity - for example Chores for seniors e.g. copying notes, cleaning rooms, etc.
4. Not being allowed to attend classes.
5. Staying awake late or getting up at unreasonable times.
6. Singing or dancing or performing in any other way.
7. Using foul language or shouting or cheering loudly.
8. Misbehaving with strangers, particularly women.

Depending upon the nature and gravity of the offence as established the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following :-

1. Cancellation of admission
2. Suspension from attending classes
3. Withholding/withdrawing scholarship/fellowship and other benefits
4. Debarring from appearing in any test/examination or other evaluation process
5. Withholding results
6. Debarring from representing the institution in any regional, national or international meet, tournament, youth festival, etc.
7. Suspension/expulsion from the hostel
8. Rustication from the institution for period ranging from 1 to 4 semesters
9. Expulsion from the institution and consequent debarring from admission to any other institution.
10. Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.

An appeal against the order of punishment by the Anti-Ragging Committee shall lie,

1. In case of an order of an institution, affiliated to or constituent part, of the University, to the Vice-Chancellor of the University;

2. In case of an order of a University, to its Chancellor.
3. In case of an institution of national importance created by an Act of Parliament, to the Chairman or Chancellor of the institution, as the case may be.

The institutional authorities shall intimate the incidents of ragging occurred in their premises along with actions taken to the Council form time to time.

An awareness program on anti-ragging was conducted on 5.10.22. Mr. V. Uma Maheshwar rao, SDPO, Nandigama, addressed the students and spoke on ragging consequences.
